Captains Meeting on Friday February 10, 2012 @ REDFISH Restaurant @6:30PM.

Entry Fee: \$500.00 WAHOO Tuna Calcutta \$100.00 Largest WAHOO Calcutta \$100.00

Note: Calcuttas end April 18, 2012 and are not eligible for the WAHOO Shootout Calcuttas.

South Carolina Wahoo Series will run from Saturday February 11, 2012 through Wednesday April 18th, 2012.

A captain may only register one boat, however crews can fish on other boats during the series.

Registration is open until 6:00PM on February 17th, 2012. You may register at Southern Drawl Outfitters in Bluffton, Redfish Restaurant on Hilton Head Island or email wahooshootout@aol.com.

Each boat will be eligible to fish a maximum of 2 days, the Captain must declare the boats fishing day by no later than 7:00PM the day before.

Notification of a fish day has to be done by emailing wahooshootout@aol.com.

Required information: Give your boat number (assigned at Captain's Meeting), marina or boat landing, and sound you are leaving and returning.

Only one Wahoo can be weighed per boat each day.

Bonus Day! By competing in the 2012 Hilton Head Harbor Wahoo Shootout as a separate tournament, your Wahoo weight will count toward the Series, giving you three days to catch two fish.

The South Carolina Wahoo Series champion will be determined by the boat with the heaviest two fish aggregate weight.

Any tie will be broken by the boat with the heaviest fish.

This is an open inlet event, boundaries are Jacksonville, FL inlet to Charleston, SC inlet.

Boats can not leave the dock on declared fish days prior to Midnight.

Boats can fish from safe light to dusk and must return to the inlet and call from a cell phone (not satellite) to check in no later then 10:00PM. Please call (843)298-0377, (843)422-5911, or (843) 384-1862 to check-in.

During the Series all fish must be weighed in at Southern Drawl Outfitters, Moss Creek Village Shopping Center, no later than 11:00AM the day after you fish. No exceptions! (The only exception being the Hilton Head Harbor Wahoo Shootout day). NOTE: Southern Drawl Outfitters are closed on Sundays. An alternate Sunday weigh-in site will be announced at the Captain's Meeting.

Fish must be caught by rod and reel. No spear guns or harpoons allowed.

A digital picture must be taken of the fish with the official boat number shortly after being caught, before you ice it down.

You may un-declare a fish day one time only, as long as no lines were deployed, by calling Marc Pincus at (843)298-0377 no later than 8am the morning of the fish day.

You may substitute a boat one time if the substitute boat is not registered in the tournament.

The committee has the right to address issues not covered in the rules and all decisions made by the committee are final.
